CERTIFICATE OF WATER RIGHT

This Is to Certify, That ROSA W. WEBB AND SETH MATTHEWS

of Jim Creek Ranch, Glide , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Jim Creek

a tributary of Little River

for the purpose of

irrigation and domestic use for one family
under Permit No. 17231 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from August 12, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.062 cubic foot per second; being 0.055 c.f.s. for irrigation and 0.007 c.f.s. for denestic use,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (NE NW), Section 11, Township 27 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.4 acres and Domestic in Lot 3 $(NE_4^{\frac{1}{4}} NW_4^{\frac{1}{4}})$ Section 11

Township 27 South, Range 3 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the Northwest corner of Lot 3 of Section 11, Township 27 South, Range 3 West, Willamette Meridian, Douglas County, Oregon; running thence South 1155 feet; thence East 1320 feet; thence North 100 feet to the center of Cavitt Creek, thence following the center of said creek downstream to the intersection of Cavitt Creek and the East Fork of the North Umpqua River, commonly known as Little River; thence following said river downstream to the North line of said Lot 3; thence West to the place of beginning, containing 32 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
