CERTIFICATE OF WATER RIGHT

This Is to Certify, That HERWIN DUNCAN

of Ironside , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two springs and reservoir constructed under Appl. No. R-25172, Permit No. R-1106 a tributary of domestic use for one family, stock and irrigation from Spring "A", and stock and irrigation from Spring "A", and stock and irrigation of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 21, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 20.5 gallons per minute, being 10.5 g.p.m. from Spring "A" and 10.0 g.p.m. from Spring "B",

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located take Spring "A": NE\(^1\) SW\(^1\), approximately 500 ft. N. and 500 ft. W. from the N.W. corner of the SW\(^1\) SE\(^1\), Section 7; Spring "B": NW\(^1\) SE\(^1\), approximately 400 ft. N. and 250 ft. E. from the N.W. corner of the SW\(^1\) SE\(^1\), Section 7, all being within Township 14 South, Range 39 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1106, and shall be still further limited to a diversion of not to exceed 20.5 g.p.m.,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

From Spring "A":

1.0 acre, Domestic and Stock in SW1 SE1 Section 7
Township 14 South, Range 39 East, W. M.

From Spring "B":

5.4 acres and Stock in NE¹/₄ SE¹/₄
1.2 acres and Stock in NW¹/₄ SE¹/₄
Section 7
Township 14 South, Range 39 East, W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
