## CERTIFICATE OF WATER RIGHT

(For rights perfected under original, enlargement or secondary permits)

This is to Certify, That GEORGE P. BARKLEY
of Riverside , State of Oregon , has made proof to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the
waters of Mud Springs , a tributary of South Fork of Malheur
, for the purpose of the irrigation of 5 acres of land
under Permit No. 1537 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered
of record in the Record of Proceedings of said Board, at Salem, in Volume 1
at page 284, on the 10th day of April, 1918; that the priority of
the right hereby confirmed dates from February 21, 1913; that the amount of
water to which such right is entitled and hereby confirmed, for the purposes uforesaid, is limited to an amount actually beneficially used for said purposes, and shall not
exceed 0.06 cubic foot per second.
A description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: Five acres in the Northeast quarter of Northeast quarter of Section Twenty-nine, Township Twenty-four South, Range Thirty-seven
East of Willamette Meridian, in Malheur County, Oregon.
