CERTIFICATE OF WATER RIGHT

This Is To Certify, That A. T. ROBERTSON

of USON Marconi Avenue, Carmichael , State of California , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Rogue River a tributary of Pacific Ocean

for the purpose of

irrigation under Permit No. 15906 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 14, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.10 cubic foot per second,

or its equivalent in case of rotation, assured at the point of diversion from the stream. The point of diversion is located in the SW4 NE4, Section 35, Township 35 South, Range 7 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 42 acre feet per acre for each acre irrigated during the irrigation season from April 2 to October 31 of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.0 acres in SW4 NE4 Section 35 Township 35 South, Range 7 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point 263 feet South of the Southeast corner of the Northwest one quarter of the Northeast one quarter of Section 35, Township 35 South, Range 7 West, Willamette Meridian; thence running West 1320 feet to the North and South center line of said Section 35; thence running South along the center line of said section, 864.7 feet to the South right of way line of a county road; thence North 66° 18' East along the South right of way line 43.2 feet; thence Northeasterly on a 2 degree curve to the left along the right of way line of the county road 430 feet thence North 57° 42' East 357.4 feet along the south right of way line of the county road; thence South 30° 49' East about 475 feet to Rogue River; thence Northeasterly along Rogue River about 900 feet to an iron stake on the North bank of Rogue River; thence North 32° 55' West about 200 feet to an iron stake directly East of the point of beginning; thence West about 395 feet to the point of beginning. Less 13.4 acres off of North side found in DR vol. 84 pg. 243 as follows: Beginning 1320 feet East and 1583 feet South of the North one quarter of Section 35 in Township 35 South Range 7 West of the Willamette Meridian; thence running West 1320 feet to the North and South line of said Section thence running South 346 feet; thence East 1302 feet; thence South 45° 40' East 122 feet to Rogue River; thence Northeasterly along Rogue River about 508 feet; thence North 22° 35' West 133 feet; thence West 416 feet to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. WITNESS the signature of the State Engineer, affixed this 30th day of State Engineer Recorded in State Record of Water Right Certificates, Volume 15
