CERTIFICATE OF WATER RIGHT

This Is To Certify, that PAUL L. AND FRANCES L. WOLF

of P. O. Box 986, Coos Bay , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream

a tributary of Isthmus Slough

for the purpose of

watering stock and flushing barns and feeding pens under Permit No. 15630 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 25, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.003 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW2 NW4, Section 23, Township 26 South, Range 13 West, W. L.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Lot 11 $(NE_4^{\frac{1}{4}} NW_4^{\frac{1}{4}})$ Section 23 Township 26 South, Range 13 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point on the West boundary of Lot 11, Section 23, Township 26 South, Range 13 West of the Willamette Meridian, a distance of 590 feet South from the iron pipe at the Northwest corner of said Lot 11 of Section 23; running thence South along said West boundary of Lot 11 of Section 23 for a distance of 723.5 feet; thence, Easterly, parallel to the North boundary of said Section 23 for a distance of 770 feet, more or less, to a point on the Westerly boundary of the right of way of the Oregon Coast Highway; thence Northeasterly along the said State Highway boundary for a distance of 758 feet, more or less, to a point which is 590 feet South from said North boundary of Section 23; thence Westerly along a line parallel to said North boundary of Section 23; thence Westerly along a line parallel to said North boundary of Section 23 for a distance of 1006 feet, more or less to the point of beginning. Containing 14.50 acres, more or less, and being a portion of Lot 11, Section 23, Township 26 South, Range 13 West of Willamette Meridian, Coos County, Oregon.

Less the following described portion thereof, to-wit:

Beginning at an iron pipe located on the West boundary of Lot 11, Section 23, Township 26 South, Range 13 West of Willamette Meridian, from which point the Northwest corner of said Lot 11 bears N. 1°344 W., a distance of 1213.50 feet;

thence, N. 1° 344' W. along the West line of said Lot 11, a distance of 265 feet; thence, N. 87° 54' E. parallel to the South line of said Lot 11, a distance of 265 feet; thence, S. 1° 344' E. parallel to the West line of said Lot 11, a distance of 265 feet to the South line of said Lot 11; thence, S. 87° 54' W. along said South line, a distance of 265 feet, to the point of beginning. Containing 1.612 acres, more or less, and being a portion of Lot 11, Section 23, Township 26 South, Range 13 West of Willamette Meridian, Coos County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
