CERTIFICATE OF WATER RIGHT

This Is To Certify, That MRS. JOE PAVLINAC

of Route 1, Box 339, Oregon City , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of en unnamed stream, tributary of Beaver Creek,

a tributary of Willamette River irrigation

for the purpose of

under Permit No. 18323 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 13, 1947 for 0.69 cubic foot per second, and July 1, 1948 for 0.08 cubic foot per second,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.77 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW SE . Section 27, Township 3 South, Range 2 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

12.6 acres in SE NW 4
29.2 acres in NE 5 SW 4
4.4 acres in SE 5 SW 4
15.2 acres in NW 5 SE 5
Section 27

Township 3 South, Range 2 East, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the center of Section 27, T. 3 S. R. 2 E. of the W.M.; thence east 20 chains; thence South 17.34 chains; thence West 22.20 chains; thence South 1.73 chains to the Northeast corner of the Cemetery Tract described in Book D, Fage 38, Deed Recards; thence west 5 chains; thence south 2.75 chains thence west 9.30 chains; to the southeast corner of a tract of land conveyed to Wm. E. Jones and wife by deed recorded Aug. 16 1926 in book 185 Page 274 Deed Records; thence north 11.9 chains to the northeast corner of said Jones Tract; thence east 12.5 chains to the northwest corner of a tract described in Book H, Page 503 Deed Records; thence south 20 rods; thence south 15° east 22.75 rods to the quarter section line; thence south 11 chains to the place of beginning except Willamette Valley Southern right of way, and subject to the rights of the public in county Roads. Containing 100 acres more or less.
