CERTIFICATE OF WATER RIGHT

This Is To Certify, That MRS. PAULINE SWARTOUT

of Route 1, Molalla, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream, tributary of Rock Creek, a tributary of Pudding River for the purpose of irrigation under Permit No. 18767 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 18, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.072 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within A. Marquam D.L.C. No. 46, Section 10, Township 6 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.4 acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within A. Marquam D.L.C. No. 46
0.4 acre in SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within A. Marquam D.L.C. No. 46
Section 10
Township 6 South, Range 1 East, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

A part of the Alfred Marquam D.L.C. in T. 6 S. R. 1 E. of W.M. more particularly described as follows:

Beginning at a stone in the South boundary of said D.L.C. 25 chains; thence South 89° 34' West from the Southeast corner of said claim; thence north 15.50 chains to a stone; thence West 1.58 chains to a stone; thence North 5.08 chains to a stone; thence East 1.58 chains to a stone; thence North 6.92 chains to a stone; thence west 0.75 chains; thence North 3.45 chains; thence East 0.75 chains; thence North 9.05 chains to the Northeast corner of a tract of land deeded to A. B. Marquam and recorded records of deeds Vol. Z. page 459, thence West 33 chains to Southeast corner of tract of land deeded to A. B. Marquam recorded records of deeds Vol. 48 page 404; thence N. 4.40 chains; thence West 4.56 chains; thence South 33° 15' East 1.40 chains; thence S. 59° 45' W. 0.57 chains to Northeast corner of a tract of land conveyed by J. E. Marquam to A. B. Marquam and recorded in record of deeds Vol. 50 page 204; thence S. 85° W. 5.70 chains; thence S. 5° E. 0.50 chains; thence N. 85° E. 4.78 chains; thence S. 10° E. 6.50 chains; thence S. 42° E. 6 chains; thence S. 10° 15' E. 15.02 chains to Northwest corner of a tract of land owned by J. E. Marquam and described in record of deeds Vol. 48 page 403; thence N. 89° 46' E. 13 chains; thence S. 17.50 chains to South boundary of said Claim; thence S. 89° 46' E. along South boundary of said Claim to place of beginning, containing 101.75 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
