CERTIFICATE OF WATER RIGHT

This Is To Certify, That VIRGINIA N. BRIDGES

of Boute 1, Box 102-C Gaston , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Tualatin River

a tributary of Willamette River

for the purpose of

irrigation
under Permit No. 20098 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from February 6, 1951

that the amount of water to wich such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.163 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 SE4, as projected within R. F. Tupper D.L.C. No. 42, Section 13, Township 1 South, Range & West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ene-eightiath of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre in SW_4^1 SE_4^1 , as projected within R. F. Tupper D.L.C. No. 42 0.6 acre in SE_4^1 SE_4^2 , as projected within R. F. Tupper D.L.C. No. 42

Section 13
3.2 acres in NE₄ NE₄, as projected within R. F. Tupper D.L.C. No. 42
8.7 acres in NW₄ NE₄, as projected within R. F. Tupper D.L.C. No. 42

Section 24
Township 1 South, Range 4 West, W. M.

Lend on which water is to be used is a part of that more explicitly described by appropriator as follows:

Lying in the SE cor. of the Robert F. Tupper PLC in Secs. 13 & 24, T. 1 S., R. 4 W. W. W., and east of the Tualatin R. and more particularly described as follows: Commencing at a point in the center of said R. on the S. side of said Tupper Claim in Sec. 24, T. 1 S., R. 4 W., W. M., and running thence E. 25 chs. to the SE Cor. of said Claim on the W. line of the W. O. Gibson Claim, thence N. 23° 15' W. on the W. line of said Gibson Claim to the center of the said Tualatin R., thence up the channel of said river to the place of beginning.

This certificate is issued to correct and supersede that certain water right certificate issued on February 26, 1954, and recorded in State Record of Water Right Certificates, Volume 15, Page 20265 so as to correctly show the lands which are located in Section 24.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
