CERTIFICATE OF WATER RIGHT

This Is To Certify, That WILLIAM H. BISHOP

of Route 2, Box 277, Central Point, State of Oregon, of a right to the use of the waters of #1 Drain Ditch, #2 Drain Ditch and an unnamed slough

a tributary of Rogue River

for the purpose of

irrigation
under Permit No. 22381 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from April 29, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.34; cubic foot per second, being 0.19 c.f.s. from #1 Drain Ditch; 0.10 c.f.s. from #2 Drain Ditch and 0.05 c.f.s. from unnamed slough;

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 SE4, Section 10; SE4 NE4 & NE4 NE4, Section 15, Township 36 South, Range 2 West, W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 42 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.6 acres in SE¹/₄ Section 10
11.4 acres in NE¹/₄ NE¹/₄
5.9 acres in SE¹/₄ NE¹/₄
Section 15
Township 36 South, Range 2 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point 45 rods west of the east boundary of the lands described in Volume 11, at page 12 of the Deed Records of Jackson County, Gregon, and running thence west 12; rods; thence south to the Rogue River; thence up Rogue River to a point 45 rods west of the east boundary of the lands described in said volume and page, and thence north to the place of beginning on the north boundary of said lands, as said premises are described in Volume 210, at page 150 of the Deed Records of Jackson County, Oregon.

Beginning at a point 35 rods west of the east boundary of the lands described in Volume 11, at page 12 of the Deed Records of Jackson County, Oregon, and running thence west on the north boundary of said lands 10 rods; thence south to Rogue River; thence up Rogue River to a point 35 rods west of the East boundary of said lands described in said volume and page; thence north to the beginning point on the north boundary of said lands.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
