CERTIFICATE OF WATER RIGHT

This Is to Certify, That LOVIE STOLLER

of Harbor , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Fish House Creek

a tributary of Chetco River irrigation

for the purpose of

under Permit No. 16659 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 1, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.015 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW No. 13. Section 4, Township 41 South, Range 13 West, W. 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 815,000 gallons per growing season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.2 acre in SW4 NW4

Township 41 South, Range 13 West, W. M.

Section 4

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

The South $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of the Northwest $\frac{1}{4}$ of the Northwest $\frac{1}{4}$, (5 acres); and the Northwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of the Northwest $\frac{1}{4}$, (10 acres), in Township 41 South, Range 13 West, W.M., Curry County, Oregon. Also: Beginning at a point on the West boundary of Section 4, Township 41 South, Range 13 West, 43.84 chains North of the Southwest corner of said Section 4; thence North 6.66 chains more or less to the South boundary of the Northwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of the Northwest $\frac{1}{4}$ of said Section 4. Thence East, 10.00 chains; Thence South, 6.66 chains, more or less to a point due East of the point of beginning; Thence West 10.00 chains to the point of beginning. Containing 6.66acres, more or less. Also: The South $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of the Northwest $\frac{1}{4}$ of Section 4. Containing 5.0 acres more or less. Also the Northwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of the Northwest $\frac{1}{4}$ of Section 4. Containing 10.0 acres more or less, Total acreage in this tract. 36.6 acres more or less.
