CERTIFICATE OF WATER RIGHT

This Is to Certify, That OLE I. STEGEN

of Route 1, Box 168, Hubbard, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rock Creek a tributary of Pudding River for the purpose of irrigation under Permit No. 16203 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 8, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.235 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 17, Township 5 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.4 acres in NE $\frac{1}{4}$ NW $\frac{1}{4}$
16.4 acres in SE $\frac{1}{4}$ NW $\frac{1}{4}$
Section 17

Township 5 South, Range 1 East, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

#1. Beginning at the NW corner of Sec. 17, T. 5 S., R. 1 E. of the W.M. running thence South 40.00 chains; thence East 20.50 chains, thence north 40.00 chains; thence west 20.50 chains to the place of beginning containing 82.00 acres, more or less, and being the W. 82.00 A. of N $\frac{1}{2}$ Sec. 17 aforesaid. #2. A part of Sec. 17, T. 5 S. R. 1 E. of W.M. more particularly described as beginning 21.01 chains east of the quarter section corner on the West line of said Section; thence North 40 chains to North boundary of said Section; thence East along said boundary line 11.25 chains; thence South 40 chains to quarter section line; thence West along said quarter section line, 11.25 chains to the place of beginning, containing 45 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
