# CERTIFICATE OF WATER RIGHT

## This Is to Certify, that CHARLES GRANT BURDEN

officiate 2, Box 14.2, Molalla , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a group of 7 springs and an unnamed stream,

a tributary of Molalla River

for the purpose of

irrigation
under Permit No. 16826 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from March 1, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.29 cubic foot per second, being 0.07 c.f.s. from springs, and 0.22 c.f.s. from stream,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NE 1/4, as projected within W. H. Vaughan D.L.C. No. 141, Section 33, Township 4 South, Range 2 East, W. N.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acrefor each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

### Irrigated from Springs:

0.8 acre in SE4 NE4, as projected within W. H. Vaughan D.L.C. No. 44, 4.5 acres in NE4 SE4, as projected within W. H. Vaughan D.L.C. No. 44, Section 33

Township 4 South, Range 2 East, W. M.

#### Irrigated from Stream:

20.4 acres in SE NE NE as projected within W. H. Vaughan D.L.C. No. 14, 0.5 acre in NE SE, as projected within W. H. Vaughan D.L.C. No. 14, Section 33

1.4 acre in SW NW 2, as projected within W. H. Vaughan D.L.C. No. 14

Section 34
Township 4 South, Range 2 East, W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
