CERTIFICATE OF WATER RIGHT

This Is to Certify, That A. B. AND LILLIAN I. THOMAS

of P. O. Box 386, Brookings, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Eiler Creek a tributary of Pacific Ocean for the purpose of irrigation

under Permit No. 17141 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 10, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.018 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 31, Township 40 South, Range 13 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.4 acre in NW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 31
Township 40 South, Range 13 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

That certain tract of land, consisting 2.56 acres, more or less, lying in Lot 3, in Section 31, Township 30 South, Range 13 West of the Willamette Meridian, in Curry County, Oregon, described as follows: Beginning at a point on the North boundary of said Lot 3 at a point South 89° 45' East 20.0 feet from the 1/4 Section corner of the West side of said Section 31; Thence South 89° 45' East 600.7 feet to an iron pipe; Thence South 2° 28' East 74.7 feet to the Westerly boundary of the County Road; Thence South 39° 50' West 156.0 feet to an iron pipe; Thence South 89° 53' West 502.7 feet to an iron pipe; Thence North 0° 15' West 197.3 feet to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
