CERTIFICATE OF WATER RIGHT

This Is To Certify, That **FREDERICK B. HILLER**

of **Newberg**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream (outlet of Skookum Lake) a tributary of Willamette River for the purpose of

under Permit No. 14895 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **April 30, 1941**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.225 cubic foot per second,**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NW $\frac{1}{4}$ SE $\frac{1}{4}$** , as projected within Geo. Alpin D.L.C. No. 64, Section 32, Township 3 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet** per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.9 acres in NE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Etiens Lucier D.L.C. No. 65
0.2 acre in Lot 3 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)
3.2 acres in NW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Etiens Lucier D.L.C. No. 65
0.4 acre in Lot 4 (NW $\frac{1}{4}$ NW $\frac{1}{4}$)
2.2 acres in Lot 5 (SW $\frac{1}{4}$ NW $\frac{1}{4}$)
0.1 acre in SW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Geo. Alpin D.L.C. No. 64
0.2 acre in NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Geo. Alpin D.L.C. No. 64
0.8 acre in NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Geo. Alpin D.L.C. No. 64
2.0 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Geo. Alpin D.L.C. No. 64
Section 32
Township 3 South, Range 2 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Within that part of the NE $\frac{1}{4}$ NW $\frac{1}{4}$, NW $\frac{1}{4}$ NW $\frac{1}{4}$, SW $\frac{1}{4}$ NW $\frac{1}{4}$, NW $\frac{1}{4}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$, and NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 32, T. 3 S., R. 2 W., W.M. situated outside of the following described tract as described in Partition Deed recorded in Vol 452, Page 267, Deed Records for Marion County, Oregon. "Beginning at an iron pipe in the center of Section 32, in T. 3 S., R. 2 W. of the W.M., Marion County, Oregon. thence S. 41°25' E. 1721.33' to an iron pipe; thence N. 72°25' E. 1004.38' to an iron pipe; thence N. 1°27' W. 936.64' to the Southerly line of the County Road leading from St. Paul to Newberg; thence N. 65°26' W. along said Southerly line, 1631.14'; thence N. 44°27' W. along the center line of the above mentioned County Road, 1920.39'; thence S. 45°33' W. perpendicular to the above mentioned center line of said County Road, 1972.30'; thence S. 44°27' E. parallel to the aforementioned center line of said County Road, 2640.00' to the South line of that certain tract of land described in Vol. 205, Page 335 of the Marion County, Oregon, Deed Records; thence N. 83°40' E. along said South line, 50.06' to an angle in said line; thence N. 41°50' E. 297.00'; thence N. 26°35' E. 165.00'; thence N. 0°30' W. 892.32' to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
