CERTIFICATE OF WATER RIGHT

This Is To Certify, That THEODORE M. BERNARDS

of **Route 1, Yamhill**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **North Yamhill River** a tributary of **Yamhill River** for the purpose of **irrigation** under Permit No. **13474** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **February 6, 1939**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **1.54 cubic foot per second,**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located ~~at~~ **at any point on appropriator's property where stream touches it in NE $\frac{1}{4}$ SE $\frac{1}{4}$, NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 6, and SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 8, and SW $\frac{1}{4}$ NW $\frac{1}{4}$, NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 9, all being within Township 3 South, Range 4 West, W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet** per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.3 acres in Lot 3 (NE $\frac{1}{4}$ SE $\frac{1}{4}$)

0.3 acre in NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within D.L.C. No. 81
16.0 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within D.L.C. No. 39
22.0 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within D.L.C. No. 39
2.2 acres in SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within D.L.C. No. 39
5.1 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within D.L.C. No. 39
8.1 acres in NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within D.L.C. No. 39

4.2 acres in SE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within D.L.C. No. 43
8.8 acres in SE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within D.L.C. No. 80
12.0 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within D.L.C. No. 80
6.5 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within D.L.C. No. 43

9.1 acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within D.L.C. No. 43
