**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That FRANCIS K. MILLER**

of 5005 S. E. Aldercrest Rd., Portland, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Little Kellogg Creek, a tributary of Kellogg Creek, a tributary of Willamette River for the purpose of irrigation under Permit No. 17929 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 5, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected within E. Kellogg D.L.C. No. 54, Section 6, Township 2 South, Range 2 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acre in NE $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected within E. Kellogg D.L.C. No. 54  
Section 6

Township 2 South, Range 2 East, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Being a part of the Elisha Kellogg D.L.C. No. 54, in T. 2 S., R. 2 E. of the W.M., Clackamas County, Oregon, bounded and described as follows, to-wit: Beginning at a basalt stone set at the southwest corner of said land claim; thence south 89° 41' East tracing the south boundary of said claim 150 feet; thence North 0° 04' West parallel to the west boundary of said claim 933.90 feet to an iron pipe; thence north 89° 41' West 150.00 feet to an iron pipe driven in the west boundary of said claim; thence south 0° 04' East tracing the west boundary of said claim 933.90 feet to the place of beginning, subject to the rights of the public in that portion thereof within the County Road.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
