## CERTIFICATE OF WATER RIGHT

## This Is To Certify, That HENRY L. DUNN

of Route 2, Box 226, Corvallis . State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Beaver Creek, tributary of Muddy Creek,

a tributary of Mary's River for the purpose of irrigation

under Permit No. 17888 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 30, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.300 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEt NEt, as projected within J. B. Irwin D.L.C. No. 43, Section 11, Township 13 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second peracre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.6 acres in SW4 NE4, as projected within J. B. Irwin D.L.C. No. 43 12.2 acres in SE, NE, as projected within J. B. Irwin D.L.C. No. 43

5.4 acres in Lot 1 (NET SET)
7.0 acres in NET SET, as projected within J. B. Irwin D.L.C. No. 43 0.2 acre in NW SE, as projected within J. B. Irwin D.L.C. No. 43

Section 11

1.0 acre in NW NW as projected within J. B. Irwin D.L.C. No. 43 1.4 acre in Lot 1 (NW NW NW NW )

Section 12 Township 13 South, Range 6 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at Southwest corner of the Donation Land Claim No. 43, Not. No. 6315, of James B. Irwin and Rebecca Jame Irwin, his wife, and running thence North on the West line of said Claim to the center of the original channel of Beaver Creek (as the same existed when said claim was located), thence in a Southeasterly direction following the center of said original channel of said Beaver Creek downstream to the intersection of said creek with the Southeast corner of said Claim, thence West on the South line of said Claim to the place of beginning, containing about 100 acres, more or less, and the intention of this description being to cover all that portion of said Claim 43 which lies South of Beaver Creek, all lying and being situated in Sections 1, 2, 11 and 12, in Township 13 South, Range 6 West, Willamette Meridian, in Benton County, State of Oregon.
