This Is to Certify, That FRANK H. PLAISTED

of Route 3, Box 478, Hillsboro , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of McKay Creek

a tributary of Tualatin River

for the purpose of

irrigation

under Permit No. 18726 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 18. 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.625 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW+ NE+, Section 30, Township 2 North, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

15.2 acres in NW NE NE 20.6 acres in NE NW NE

13.9 acres in Lot 2 (SW NEt)

0.3 acre in SEL NW

Township 2 North, Range 2 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:
