CERTIFICATE OF WATER RIGHT

This Is To Certify, that CARLETON PARISH PYNN, M.D.

of Route 1, Box 478, West Linn , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Willamette River a tributary of Columbia River

for the purpose of

irrigation under Permit No. 18840 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 14, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE_{+}^{1} SE_{+}^{1} , as projected within G. Brock D.L.C. No. 46, Section 22, Township 3 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.3 acres in SW, NE, as projected within G. Brock D.L.C. No. 46
16.0 acres in SE, NE, as projected within G. Brock D.L.C. No. 46
2.6 acres in NE, SE, as projected within G. Brock D.L.C. No. 46
1.1 acres in NW, SE, as projected within G. Brock D.L.C. No. 46
Section 22

Township 3 South, Range 1 East, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Part of the George Brock D.L.C. #46 in Sections 15 and 22, Township Three (3) South

Part of the George Brock D.L.C. #46 in Sections 15 and 22, Township Three (3) South of Range One (1) East of the Willamette Meridian, described as follows:
Beginning at a point 100 feet North of a forty foot roadway across the South side of Tracts Sixty Seven (67) and Seventy Nine (79) of what was formerly Peach Cove, according to the duly recorded plat thereof, now vacated, which beginning point is further described as being 140 feet North of the Southwest corner of said tract 67; thence running East parallel with the South boundary of tracts 67, 79 and 87 of said Peach Cove, to the Willamette River; thence Northerly along the East end of what was formerly tract 87 of Peach Cove lying North of the above line and Northerly along the East end of tracts 86, 85, 84, 83 and 82 to the Northeast corner of tract 82, thence West along the North side of tracts 82, 81 and 65 of what was formerly Peach Cove now vactaed to the Northwest corner of tract 65; thence South along the West end of Tracts 65, 66, 67 to place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
