CERTIFICATE OF WATER RIGHT

This Is to Certify, That LELAND W. PETTECHEN

, State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream

a tributary of Winchuck River for the purpose of irrigation and domestic use for two families under Permit No. of the State Engineer, and that said right to the use of said waters 18907 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 27, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL SEL Section 13, Township 41 South, Range 13 West. W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be-limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 13.3 acres and Domestic in Lot 12 (NW2 SW2) Section 7

Township 41 South, Range 12 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

ts numbered Five (5), Twelve (12) and Thirteen (13) in Section Seven (7), Township Forty-one (41) South, Range Twelve (12) West of the Willemette Meridian, excepting therefrom 41.71 acres, more or less, described as follows: Beginning at a point on the West boundary of Section Seven (7) in said Township and Range; which said point of beginning is 1435.81 feet North of the Southwest corner of said Section Seven (7); Thence South 80 dag. 53 min. East 1368.84 feet, more or less, to the East boundary of said Lot number Thirteen (13); Thence South along said east boundary of said Lot numbered Thirteen (13), 1245.07 feet, more or less, to the Scutheast corner of said Lot number Thirteen (13); Thence West 1353 feet, more or less, to the said Scuthwest corner of said Section Seven (7); Thence North along the West boundary of said Section Seven (7). 1.35.81 feet to the place of beginning.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place of

use herein described.
