## This Is To Certify, that ALBERT CLAY ENGLE

of Route 2, Box 240, Molalla , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed spring and reservoir constructed under Appl. No. 11-15457, Permit No. R-1201 a tributary of Molalla River

under Permit No. 20505 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from September 27, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.045 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL SEL, as projected within A. J. Beattie D.L.C. No. 54, Section 14, Township 5 South, Range 2 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1201,

conform to such reasonable rotation system as may be ordered by the proper state officer.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: A part of the D.L.C., of Andrew J. Baty, and wife in Sections 13, 14, 23 and 24 in

T. 5 S, R. 2 E., W.M., described as follows, to wit:—
Beginning at a point in the center line of the Dickey Prairie and Meadowbrook County
Road where said center line intersects a line running parallel with the South line of
said D.L.C. And dividing the South half of said D.L.C., into North and South halves,
said point being the southwest corner of said lands conveyed by granters herein to
Charlotte D. Rastall as described in Book 172, page 15 deed records of said County
and State; thence South 65 degrees 30' West along said dividing line 2061 feet to the
Westerly line of said D.L.C. thence Northerly along the Westerly line of said D.L.C.,
24.9375 chains to the line running parallel to the south line of said D.L.C., and
dividing said D.L.C. into North and South halves; thence Easterly along said dividing
