CERTIFICATE OF WATER RIGHT

This Is to Certify, That RALPH W. PIERSON

of Route 2, Box 7, Aurora , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pudding River

a tributary of Willamette River

for the purpose of

irrigation
under Permit No. 1927. of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from February 16, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.225 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW_{+}^{1} NE_{+}^{2} , Section 12, Township 4 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.0 acres in SEL NEL 4.4 acres in NWL NEL 8.6 acres in SWL NEL

Section 12

Township 4 South, Range 1 West, W. M.

Land on thich water is to be used is a part of that more explicitly described by appropriator as follows:

Parcel No. 1: Beginning at the Southwest corner of the Southeast ½ of the Northeast ½ of soction 12 in T. 4 S., R. 1 W. of the WM. Clackamas County Oregon; thence N. 35° 00° E. 18.50 chains; thence West 10.92 chains to the East line of G. Arndts' land; thence South 14.92 chains to the point of beginning.

Parcel No. 2: Beginning at the Northeast corner of the West 1 of the Northeast 1 of section 12 in T4s, K1W of the WM. Clackamas County Oregon; thence West 8.19 chains to the center line of the of the Pudding river thence upstream to the intersection of the South line of aforesaid 2 section; thence East to the Southeast corner of the West 2 of said 4 section; thence North 40.00 chains to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
