**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** CLAUDE SHAFFER

of Route 2, Box 232, Aurora, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River a tributary of Columbia River for the purpose of irrigation under Permit No. 19703 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 13, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.013 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  SE $\frac{1}{4}$ , as projected within J. Boone D.L.C. No. 42, Section 22, Township 3 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be still further limited to a diversion of not to exceed 0.013 c.f.s.,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acre in SE $\frac{1}{4}$  SE $\frac{1}{4}$ , as projected within J. Boone D.L.C. No. 42  
Section 22

Township 3 South, Range 1 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point on the West line of the land of A. M. Haradon and Delia H. Haradon, and on the South side of the Willamette River, which point is N. 1 degree 08' W. 3054.62 feet more or less and N. 53 degrees 01' 30" E. 814.14 feet more or less and N. 1 degree 08' W. 2116.46 feet more or less from a stone at the southwest corner of the Jessie V. Boone D.L.C.; thence Easterly along the Willamette River 436 feet more or less to the corner of land sold on contract to Joe Edward Hughbank and Mildred Lenore Hughbank, husband and wife, by contract recorded August 4, 1947, in Book 20 of Misc. at page , records of Clackamas County; thence Southerly along the West line of said Hughbank land 280 feet more or less to the South side of the Wilsonville-Butteville County Road; thence Westerly along the South side of said road 435 feet more or less to the West line of said Haradon land; thence North on the West line of said Haradon Land 252 feet more or less to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
