CERTIFICATE OF WATER RIGHT

This Is to Certify, That R. C. SCHREIBER

of Route 2, Corvallis, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Squaw Creek a tributary of Mary's River for the purpose of irrigation under Permit No. 19901 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 8, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.188 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within P. Scott D.L.C. No. 44, Section 4, Township 12 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.4 acres in SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within P. Scott D.L.C. No. 44
4.6 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within P. Scott D.L.C. No. 44
Section 4

Township 12 South, Range 5 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning 23.06 ch. S. & 21.992 W. of N.E. Corner of Prior Scott claim #44 - T 12 S R 5 W thence S 2' M. West 24.893 chains to center of County R. So. 72 degrees & 24' M. West 24.311 chains N 6' M East 32.249 chains N. 89 degrees 58' N East 23.195 chains to beginning, containing 66.253 A.

Except the tract of land described in deed recorded in Book 96, Page 137, Benton County Deed Records, leaving a net area of 65.87 Ac.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
