CERTIFICATE OF WATER RIGHT

This Is To Certify, That HOWARD L. BROWNSON

of Myrtle Creek , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Myrtle Creek

a tributary of South Umpqua River irrigation

for the purpose of

under Permit No. 19302 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 14, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.8 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL NWL, as projected within W. Weaver D.L.C. No. 39, Section 21, Township 29 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be still further limited to a diversion of not to exceed 0.8 c.f.s.,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

14.6 acres in NW4 NE4, as projected within W. Weaver D.L.C. No. 39
3.8 acres in SW4 NE4, as projected within W. Weaver D.L.C. No. 39
29.2 acres in NE4 NW4, as projected within W. Weaver D.L.C. No. 39
16.6 acres in SW4 NW4, as projected within W. Weaver D.L.C. No. 39
2.2 acres in SE4 NW4, as projected within W. Weaver D.L.C. No. 39

Township 29 South, Range 4 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

The Northwest Quarter of the Northeast Quarter (NW, NE, the East half of the Northwest quarter (E, NW,); the Southwest quarter of the Northwest quarter (SW, NW); the North half of the Southwest quarter (N, SW,); and Lots Numbered Two (2), Three (3) and Four (4), Section Sixteen (16) Township Twenty-nine (29) South, Range Four (4) West of the Willamette Meridian, containing 335.96 acres, more or less.

Also that part of Donation Land Claim Number Thirty-nine (39) in Township Number Twenty-nine (29) South, Range Four (4) West of the Willamette Meridian, indicated in Sections Numbered Sixteen (16) and Twenty-one (21) of said Township, containing 241.20 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
