CERTIFICATE OF WATER RIGHT

This Is To Certify, That CECIL C. SNYDER

of Route 2, Box 54, Molalla ,State of Oregon ,has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Molalla River

a tributary of Willamette River

for the purpose of

irrigation under Permit No. 2067 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 21, 1954

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.15 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEL NEL, as projected within C. Sweigle D.L.C. No. 53, Section 15, Township 5 South, Range 2 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

12.0 acres in NE! NE!, as projected within C. Sweigle D.L.C. No. 53
Section 15
Township 5 South, Range 2 East, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Part of the Charles Swegle D.L.C. #53 and Part of the Mathias Swegle D.L.C. #45 in T. 5 S. R. 2 E. of the W.M. described as:

Beginning at the most northerly northwest conner of the Charles Swegle D.L.C. # 53 in Section 10, T. 5 S. R. 2 E. of the W.M., thence S. 89 deg. 30' W. along the northerly line of that tract of land conveyed to Charles Swegle, by deed recorded Jan. 22, 1856 in book "B" at page 201, Clackamas County records, 5.45 chains, more or less, to Market Road No. 32; thence S. 51 deg. 30' W. along said road 24.25 chains, more or less, to the south line of the Mathias Swegle D.L.C. #45; thence S. 18 deg. 30' W. along the west line of the Charles Swegle D.L.C. #53 a distance of 27.05 chains, more or less, to the southwest corner of said Charles Swegle D.L.C. to the southwest corner of the plat of Shady Dell in Flat Book 18 at page 14, replatted as Replat of Shady Dell in Flat book 22 at page 1, records of Clackamas County, Oregon; thence northerly along the west line of said plat of Replat of Shady Dell to the north line of the Charles Swegle D.L.C. # 53; thence S. 88 deg. 15' W. on claim line to the place of beginning.
