CERTIFICATE OF WATER RIGHT

This Is To Certify, That OREGON STATE HIGHWAY COMMISSION

of Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed creek a tributary of Wallowa Lake for the purpose of public park purposes in Wallowa Lake State Park under Permit No. 21554 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 25, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.50 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SE 1/4, Section 20, Township 3 South, Range 45 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Section 20

Township 3 South, Range 45 East, W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at corner No. 1 which bears North 28 deg. 54' West. 1143 feet from the Northwest corner of the Northeast quarter of the Northeast quarter (NE 1/4 NE 1/4) of Section 29, Township 3 South, Range 45 East, W.M., running thence North 14 deg. 57' East 295.2 feet; thence South 75 deg. 03' West, 295.2 feet; thence South 14 Deg. 57' West, 295.2 feet; thence North 75 deg. 03' East, 295.2 feet to the place of beginning, containing 2 acres, more or less.

ALSO: Beginning at a point on the westerly boundary line of the southeast quarter (SE 1/4) of Section 20, Township 3 South, Range 45 East, W.M., said point also being 1479 feet north and 9 feet east of the south one-quarter corner of said Section 20; thence North 0 deg. 22' East along said westerly boundary line a distance of 1230 feet to the center of said Section 20; thence South 87 deg. 45' East along the northerly boundary line of said southeast quarter (SE 1/4) a distance of 1129 feet; thence North 0 deg. 16' West parallel to and 1485 feet westerly from the east line of said Section 20 to the intersection of the meander line of Wallowa Lake; thence easterly along the meander line of Wallowa Lake to the intersection of a line drawn parallel to and 825 feet westerly from the east line of said Section 20; thence south 0 deg. 16' East along said parallel line to the intersection of the northerly boundary line of said southeast quarter (SE 1/4); thence south 0 deg. 16' East along said parallel

line a distance of 660 feet; thence North 87 deg. 45' West a distance of 165.7 feet; thence South 7 deg. 40' West a distance of 569 feet; thence North 87 deg. 53' West a distance of 1557.7 feet to the point of beginning; containing 55 acres, more or less. Subject to all valid existing flood rights and existing water pipe and power pole easements.

ALSO: Beginning on the South line of Said Lot 2 at a point which is 1129 feet East of the Southwest corner of Lot 2; thence North 87 deg. 45' West along the South line of Lot 2, approximately 389 feet to the high water line of Wallowa Lake; thence Northerly along said high water line 400 feet; thence Easterly approximately 40 feet to the low water or meander line of said Lake; thence Easterly following the said meander line to a point which is North 0 deg. 16' West of the point of beginning; thence South 0 deg. 16' East to the point of beginning, containing 3.0 acres.

ALSO: Beginning at the East quarter corner of said Section 20; thence North 87 deg. 45' West along the South line of said Lot 3 a distance of 825 feet; thence North 0 deg. 16' West to the meander line of Wallowa Lake; thence Easterly following said meander line to a point which is due North of the point of beginning; thence South to the point of beginning, containing 3.6 acres.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
