CERTIFICATE OF WATER RIGHT

This Is To Certify, that CLACKAMAS FLAX GROWERS

of Canby , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Molalla River

a tributary of Willamette River

for the purpose of

irrigation

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.367 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SEL NWL, Section 10, Township 4 South, Range 1

East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

29.2 acres in SE¹₄ NW¹₄ Section 10 Township 4 South, Range 1 East, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

A part of the Southeast Quarter of the Northwest Quarter of Section 10, T 4 S, R 1 E, of the W.N. and more particularly described as follows: Beginning at a stone with a cross marking the southeast corner of said southeast quarter of the Northwest quarter and center of Section 10, thence north 1,316 feet tracing the north and south one-half section line to a point from which a ½ inch iron pipe bears west 77 feet; thence West 1.220 feet, tracing the north line of the south one-half of the northwest quarter of said Section 10 to 3/4 inch iron pipe; thence south 1,194.5 feet on a line parallel with and 200 feet east of the west line of said southeast quarter of the northwest quarter to a point in the center of the C. C. Knutson County Road from which point a 3/4 inch iron pipe bears north 38.1 feet thence south 31 degrees 50 minutes east 172.2 feet, tracing the center of said County Road to a point in the south line of the north one-half of said Section 10, thence east 1,044 feet to the place of beginning, containing 33.85 acres more or less, subject to the rights of the public in the C. C. Knutson County Road and subject to an easement from Edward G. Miller and Rebecca A. Miller to Molalla River District Improvement Company of the County of Clackamas, State of Oregon, an Oregon corporation recorded June 2, 1938 in Book 247, Page 309 Deed Records

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
