CERTIFICATE OF WATER RIGHT

This Is to Certify, That MONROE UNION HIGH SCHOOL

of District No. 1, Monroe , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Long Tom River

a tributary of Willemette River

. for the purpose of

irrigation

under Permit No. 21736 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 26, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.045 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL SEL, Section 28, Township 14 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.6 acres in SWA SEA Section 28

Township 14 South, Range 5 West, W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point in the center line of the State highway 2.872 chains North of the line between Sections 28 and 33, T. 14 S., R. 5 W. of the Will. Mer. in Benton County, Oregon; and running thence North 11 degrees 02' West along the Center line of said highway 7.931 chains to the south line of the Pacific addition to Monroe; thence N. 89 degrees 53' E. along said line 13.59 chains to the center line of Long Tom River; thence up the center line of said streams S. 21 degrees West .861 chains S. 32 degrees W. 2.20 chains, and S. 23 degrees 30' W. 5.643 chains to a point 2.872 chains North of the section line; thence North 89 degrees 45' W. parallel to said section line 8.345 chains to the place of beginning, containing 8.5 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
