## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That SAILY B. AND RICHARD E. RATHBUN

of R.F.D., Joseph , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Newby Creek

a tributary of Wallowa River for the purpose of domostic use for one family, including irrigation of not to exceed a acre law & garden under Permit No. 22002 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 29, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 6 (NEL NWL), Section 1, Township 3 South, Range 44 East, N. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ---- of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Lot 6 (NE1 NW1)
Section 1.
Township 3 South, Range 44 East, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point which is South 888.0 feet and West 25.0 feet from the Northeast corner of the Northwest quarter of Section 1, Township 3 South, Range 44 East, Willamette Meridian; thence West 265.0 feet and parallel to the North boundary of Lot 6, Section 1, Township 3 South, Range 44 East, Willamette Meridian; thence South 150.0 feet and parallel to the West boundary of Lot 6, Section 1, Township 3 South, Range 44 East, Willamette Meridian; thence East 265.0 feet and parallel to South boundary of Lot 6, Section 1, Township 3 South, Range 44 East, Willamette Meridian; thence North 150 feet and on East boundary of Lot 6, Section 1, Township 3 South, Range 44 East, Willamette Meridian to place of beginning, together with right to use of roadway adjoining above described tract on East. Subject to rights of way of record.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
