**CERTIFICATE OF WATER RIGHT**

**This Is To Certify, That E. H. DUYCK**

of Route 1, Banks, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of East Fork Dairy Creek, a tributary of Dairy Creek for the purpose of irrigation under Permit No. 18446 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 6, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.362 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within John Northrop D.L.C. No. 76, Section 3, Township 1 North, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 2.4 acres in SW $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected within John Harrison D.L.C. No. 37  
Section 34  
Township 2 North, Range 3 West, W. M.
- 2.6 acres in NW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within John Harrison D.L.C. No. 38  
Section 3
- 24.0 acres in NE $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected within John Northrop D.L.C. No. 44  
Section 4  
Township 1 North, Range 3 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the N. E. corner of the Wm. Wilson D.L.C. and running thence N. 77° 22' W. 1223.6 feet to a stone 6" x 8" set flush with the surface of the ground; thence N. 0° 0' W. 1827.4 feet to a white stake, thence N. 90° E. 2444.3 feet to a white stake, thence S. 77° 15' E. 282.5 feet to a white stake, thence S. 14° 30' W. 999.9 feet to a white stake on the N. bank of Dairy Creek, thence in a southwesterly direction along the N. bank of said Dairy Creek 311.5 feet to a white stake, thence S. 13° 55' W. 643.5 feet to the center of Dairy Creek, thence in a southwesterly direction along the center line of said Dairy Creek 966.9 feet to a white stake thence N. 85° 37' W. 22.5 feet to a point of beginning, containing in all 105 acres.

That I have marked with proper monuments the corners thereof and drove an iron pipe 2 in. diameter and 36" long 6" below the surface of the ground at the initial point.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
