CERTIFICATE OF WATER RIGHT

This Is To Certify, That HAROLD H. AND RHODA L. MEYERS

of **Route 5, Hillsboro**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Tualatin River** a tributary of **Willamette River** for the purpose of **irrigation** under Permit No. **13443** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **January 17, 1939**

; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.50 cubic foot per second,**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 21, Township 1 South, Range 2 West, W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,**

and shall conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**31.0 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$
9.0 acres in Lot 1 (SW $\frac{1}{4}$ SW $\frac{1}{4}$)
Section 21
Township 1 South, Range 2 West, W. M.**

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point marked by a 2" iron pipe replacing an iron pipe set in County Survey No. 1920 at the one-quarter section corner between Sections 20 and 21; Thence South 1° 09' 00" West 1665.14 feet along the section line to a point marked by a 3/4" iron pipe; Thence South 88° 51' 00" East 1430.94 feet along the line common with United States Farm Security Administration Farm Unity No. 94 to a point on the center line of the Tualatin River, said point being witnessed by a 3/4" iron pipe set back on line 130.00 feet; Thence meandering the center line of the Tualatin River as follows: North 12° 53' 41" West 25.85 feet; North 6° 06' 33" West 249.96 feet; Thence, leaving the center line of the River, North 88° 51' 00" West 113.72 feet to a point marked by a 2" iron pipe, said point being the Northeast corner of Government Lot 1; Thence North 1° 46' 02" East 1398.03 feet along the line common with the Frank and Frances Setniker property to a point marked by a 2" iron pipe which replaces a post set in County Survey No. 705; Thence North 89° 06' 32" West 1294.46 feet along the line common with the L. J. and Estella Panchachar property and the George and Clara Hagen property to the point of beginning; This Unit contains 50.055 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
