## CERTIFICATE OF WATER RIGHT

## This Is To Certify, That U. D. BRUMBELOE

of Route 2, Box 634, Grants Pass , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of The Canyon

a tributary of Applegate River irrigation

for the purpose of

under Permit No. 21765 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 10, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEE SWE, Section 20, Township 36 South, Range 6 West, N. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 42 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.0 acres in NET SWA 1.5 acres in SEA SWA Section 20 Township 36 South, Range 6 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point on the center line of the Sect on which bears North 0° 22' East 833 feet from the South Quarter corner of Section 20, Township 36 South Range 6 West of the Willamette Meridian; thence North 0° 22' East 483 feet to the Southeast corner of Tract 11, Apple Rogue Subdivision; thence North along the East line of said Tract 380.8 feet to a point in the center of the Leonard Irrigation lateral thence following the center line of said lateral as near as may be South 89° 36' West 284 feet; thence south 67° 57' West 140 feet; thence South 74° 09' West 220 feet to a point on the West line of said Tract 11 thence South 266.8 feet to the Southwest corner of said Tract 11; thence East 125 feet along the South line of Tract 11 to a point in the County Road; thence South 43° 40' East 305.5 feet along road; thence South 8° 42' West 265 feet along the road; thence East 326 feet to the point of beginning, less and excepting the right of way of the County Road, containing 8.5 acres, more or less; Also easement for a ditch now in existence to convey irrigation water therein in a Northeasterly direction across the 3 acres of the grantors lying contiguous and South of the conveyed land diversion to be near intersection of Canyon Creek with South line of said 3 acres, with the right of ingress and egrss for repairs.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
