CERTIFICATE OF WATER RIGHT

This Is To Certify, That MYRTLE I. WILSON

of Route 1, Box 361, Medford , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unmaned spring, a tributary of Griffin Creek,

a tributary of Bear Creek

for the purpose of

irrigation
under Permit No. 20568 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from June 21, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.341 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE^{1}_{+} NW^{1}_{+} , Section 2, Township 38 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season of each year, provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.50 acres in SE½ NW½ 8.40 acres in NE½ SW½ 5.85 acres in SW½ NW½ 8.55 acres in NW½ SW½ Section 2

Township 38 South, Range 2 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at an iron pin on the west line of Donation Land Claim No. 40 in Township 38 South, of Range 2 West of the Willamette Meridian, in Jackson County, Oregon, which is 718.7 feet North of the Southwest corner of said Donation Land Claim No. 40; and running thence West 218 feet; thence South 173.5 feet; thence West on the South line of Donation Land Claim No. 45, same Township and Range, 1292.5 feet; thence North 405.5 feet; thence East 92 feet; thence North 14 degrees 4 East 218 feet; thence East 517 feet; thence South 77 feet; thence North 87 degrees 21 East 850 feet; thence South, on the west line of Donation Land Claim No. 40, 400.76 feet to the point of beginning;

TRACT B: Beginning at a point 124 feet South of the Northeast corner of Donation Land Claim No. 46 in Township 38 South, of Range 2 West of the Willamette Meridian; in Jackson County, Oregon; running thence South, along the center of the County road; 302 feet; thence South 89 degrees 30' West 1322 feet to Griffin Creek; thence down Griffin Creek, North 7 degrees 47' West 100 feet, North 13 degrees 36' West 100 feet, North 7 degrees 47' West 232.9 feet to the north line of Donation Land Claim No. 46; thence North 89° 49' East, along the North line of said Claim, 1207 feet; thence South 0° 50' West 121.8 feet; thence North 89° 15' East 185.3 feet to the point of

beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
