CERTIFICATE OF WATER RIGHT

This Is To Certify, That HOWARD M. KNAPP

of Route 2, Box 36X, Grants Pass, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River a tributary of Pacific Ocean for the purpose of irrigation under Permit No. 21882 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 12, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.20 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NE $\frac{1}{4}$ NE $\frac{1}{4}$), Section 21, Township 36 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.2 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$
 0.3 acre in Lot 7 (SW $\frac{1}{4}$ SE $\frac{1}{4}$)
 Section 16
 10.8 acres in Lot 1 (NE $\frac{1}{4}$ NE $\frac{1}{4}$)
 1.7 acres in Lot 2 (NW $\frac{1}{4}$ NE $\frac{1}{4}$)
 2.0 acres in Lot 3 (NW $\frac{1}{4}$ NW $\frac{1}{4}$)
 Section 21
 Township 36 South, Range 6 West, W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Parcel 1: A tract of land situated partly in the SE $\frac{1}{4}$ and partly in Government Lot 7 of Sec. 16, T. 36 S., R. 6 W., W.M., described as follows: Beginning at a point 44 rods W. of the SE corner of the SE $\frac{1}{4}$ of said Section and running thence N. on the line between the lands formerly owned by C. H. Garner and C. N. Gilman, a distance of 90 feet; thence W. a distance of 719.4 feet, more or less, to the line of that parcel of land conveyed to A. N. Hulbert by deed recorded in book 17 at page 227; thence S. 90 feet; thence E. a distance of 719.4 feet, more or less to the point of beginning.
 Parcel 2. A part of Government Lot 7, Sec. 16, T. 36 S., R. 6 W., W.M., described as follows: A parcel of land for roadway described as beginning at the NW corner of Parcel 1, and run thence N. 1230 feet, more or less to the center of the present county road; thence E. 1 rod; thence S. 1230 feet, more or less to the N. line of the Tract first described; thence W. 1 rod to the point of beginning.
 Parcel 3: A part of Government Lot 2, Sec. 21, T. 36 S., R. 6 W. of the Willamette M., described as follows: Beginning at the NE corner of said Lot and run thence

W. 10 rods; thence S. parallel with the E. line of Lot 2 to the meander line of Rogue River; thence E. along the meander line of Rogue River to the SE corner of said lot; thence N. to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
