of P. O. Box 361, Grants Pass , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean irrigation

for the purpose of

under Permit No. 22127 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 16, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.225 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 SE4 and NE4 SW4, Section 24, Township 36 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 42 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point 20 feet N. and 350 feet E. of the center of Sec. 24, T. 36 S., R. 5 W., W.M., Oregon said beginning point being on the S. line of the County Road, and running thence N. 84° E. 178 feet; thence E. 175 feet; thence S. 76° E. 178 ft; thence S. 66° E. 195 feet; thence S. to the N. bank of Rogue River; thence westerly along the northerly bank of Rogue River to a point directly S. of the place of beginning; thence N. to the place of beginning. Also, beginning at a point on the S line of the County Road 175 feet E. of the center of Sec. 24 in T. 36 S., R. 5 W., W.M. and running thence S. 84° W. 178 feet to a point directly S. of the center of said section 24; thence S. to the N. bank of Rogue River; thence easterly along the N. bank of Rogue River to a point which is directly S. of the point of beginning; thence N. to the point of beginning. Also, beginning at a point which is 350 feet E. and 20 feet N. of the center of Sec. 24, T. 36 S., R. 5 W., W.M., and running thence S. 84° W. 178 feet; thence S. to the N. bank of Rogue River; thence easterly along the N. bank of Rogue River to a point which is directly S. of the point of beginning, and 175 ft. E.

at right angles from the W. line of the tract hereby conveyed; thence N. to the point of beginning, containing 1.3 acres, more or less. Also, all of Lots 1 and 2 in W.B. Sherman's subdivision No. 8 in Sec. 24, T. 36 S., R. 5 W., W.M., Josephine County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
