**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** RAYMOND A. ROBBINS

of Sunny Valley, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed creek, a tributary of Grave Creek for the purpose of irrigation under Permit No. 21276 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 31, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.175 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 9, Township 34 South, Range 5 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

11.7 acres in NE $\frac{1}{4}$  NE $\frac{1}{4}$   
0.6 acre in SE $\frac{1}{4}$  NE $\frac{1}{4}$   
Section 8  
1.7 acres in NW $\frac{1}{4}$  NW $\frac{1}{4}$   
Section 9

Township 34 South, Range 5 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

The North half of the North half and all that portion of the South half of the Northwest quarter of Section 9, lying and being North of the center of Grave Creek as the same now runs, all being in Section 9, in Township 34 South Range 5 West of the Willamette Meridian, Oregon. Also beginning at the Northeast corner of Section 8, in Township 34 South Range 5 West of the Willamette Meridian and run thence West 5.84 chains; thence South 9.13 chains; thence West 4.50 chains; thence South 16° West, 11.35 chains; thence South to the center of Grave Creek; thence Easterly along the center of Grave Creek 13.50 chains more or less to the East line of said Section 8 thence North to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
