CERTIFICATE OF WATER RIGHT

This Is to Certify, That F. W. HOPKINS

of Sunny Valley, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Spring Creek, a tributary of Grave Creek for the purpose of irrigation under Permit No. 22584 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 3, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.038 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 12, Township 34 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.3 acre in SE $\frac{1}{4}$ NE $\frac{1}{4}$

Section 11

2.7 acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$

Section 12

Township 34 South, Range 6 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point from which the North Quarter corner of section 11, Township 34 South, Range 6 West of the Willamette meridian, bears North 41°17' West 9.677 chains and run South 58°25' East 1549.4 feet to the true point of beginning; thence South 62° 53' East 1320 feet along the County Road; South 814 feet to the East and West center line of Section 11 and 12; West to a point South of beginning; North 80 rods to beginning, in Sections 11 and 12 Township 34 South Range 6 West of the Willamette Meridian/

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
