CERTIFICATE OF WATER RIGHT

This Is To Certify, That CHAVNER THOMPSON

of P.O. Box 554, Gold Hill , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two springs and Blackwell Creek

a tributary of Rogue River

for the purpose of

irrigation and domestic use for two families and stock of the State Engineer, and that said right to the use of said waters under Permit No. 1744 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 23, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second, being 0.18 c.f.s. from creek; 0.03 c.f.s. for domestic and stock use from Spring No. 1; and 0.03 c.f.s. for irr_gation and 0.01 c.f.s. for stock use from Spring No. 2,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the from Spring No. 1 (east) in the NE | NE | from Spring No. 2 (west) in the NW N Wa; from Blackwell Creek in the NW SW, all being within Section 23, Township 36 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second peracre, for each acre irrigated and shall be further limited to a diversion of not to exceed 42 acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
