This Is to Certify, That HERBERT WRAY AND/OR ETHEL JUNE LESTER

of Route 3, Corvallis , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Muddy Creek

a tributary of Mary's River

for the purpose of

irrigation

under Permit No. 19505 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 22, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.293 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEL SEL as projected within G. L. Boone D.L.C. No. 42, Section 8, Township 13 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.6 acres in SE_4^1 NE_4^1 , as projected within G. L. Boone D.L.C. No. 42 1.8 acres in NE_7^1 SE_4^1 , as projected within G. L. Boone D.L.C. No. 42

9.0 acres in SW1 NW2, as projected within G. L. Boone D.L.C. No. 42 6.0 acres in NW2 SW2, as projected within G. L. Boone D.L.C. No. 42

Section 9 . Township 13 South, Range 5 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the N.W. corner of G. I. Boone Cl. #42, T 13 S.R 5 W., thence S. 9.50 chs. W. 56.90 chs to centerof Middy Creek downstream to point 30.70 chs S. of N. line of said Cl. #42, thence N 87° E. 14.80 chs, thence N 5.80 chs, thence N. 87° 30° E. 44.40 chs; thence N. 3.75 chs, thence N 87° 30° E 24.90 chs, thence N 16.25 chs to center of county road, thence W 108.35 chs to beginning. Exc. Lot 3 Sec 9 T. 13 S.R. 5 W., 2 acres in Grange Hall tract, and 58.194 acres sold to W. A. Whitney off E. end, leaving 242 acres in Benton County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
