CERTIFICATE OF WATER RIGHT

This Is To Certify, That v. g. CLEIM AND E. L. BLEVINS

of Route 1, Box 87, Murphy , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Applegate River a tributary of Rogue River

for the purpose of

irrigation and supplemental irrigation
under Permit No. 22831 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from April 12, 1954

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.20 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWL NEL, Section 1, Township 38 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightlieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season of each year, provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

PRIMARY

7.0 acres in SE¹ SE¹ Section 35
Township 37 South, Range 5 West, W. M.

SUPPLEMENTAL

9.0 acres in NE¹/₄ NE¹/₄
Section 2
Township 38 South, Range 5 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Parcel 1. All that portion of the Southeast quarter of the Southeast quarter of Section 35, Township 37 South Range 5 West of the Willamette meridian, lying South of the Applegate River.

Parcel 2. All that portion of the Southwest quarter of the Southwest quarter of Section 36, Township 37 South Range 5 West of the Willamette meridian, lying South of the Applegate River.

Parcel 3. All that portion of the Northeast quarter of the Northeast quarter of Section 2, Township 38 South Range 5 West of the Willamette Meridian lying North and East of the County Road as established by deed to the State of Oregon in Deed Records Vol. 84 page 251

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
