CERTIFICATE OF WATER RIGHT

This Is To Certify, That GLENN CRISELL

of Route 2, Aurora , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River a tributary of Columbia River for the purpose of

irrigation under Permit No.

19777 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

August 15, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.802 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SEL SEL, as projected within J. Boone D.L.C.

No. 42, Section 22, Township 3 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

11.4 acres in SE¹/₄ SE¹/₄, as projected within J. Boone D.L.C. No. 42
5.0 acres in Lot 4 (SW¹/₄ SE¹/₄)
Section 22
22.2 acres in NW¹/₄ NE¹/₄
18.6 acres in NE¹/₄ NE¹/₄, as projected within J. Boone D.L.C. No. 42
3.0 acres in SW¹/₄ NE¹/₄

0.4 acre in SE¹/₄ NE¹/₄
Section 27
Township 3 South, Range 1 West, W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

An undevided one-half of the following: Beginning at an iron pipe on the South line of Section 27, T. 3 S, R. 1 West of the Willamette Meridian, that is 573.54 feet East of the quarter Section corner between Sections 27 and 34 of Tp. 3 South, of Range 1 West of the Willamette Meridian; thence East 362.01 feet along the South line of said Section 27 to a point; thence North 32 degrees 51 East 707.67 feet to a point; thence North 3114.76 feet to an iron pipe; thence North 54 degrees 10' East 814.09 feet to a point; thence North 2195.18 feet to a point on the South side of the Willamette River; thence following the South side of the Willamette River upstream South 73 degrees 48' West 395.43 feet to a point; thence continuing along the South side of the Willamette River upstream 57 degrees 00' West 1582 feet to a point; thence South 19 degrees 00' East 316.34 feet to a point; thence East 198.00 feet to a point; thence South 5109.72 feet to the point of beginning; containing 123.73 acres, more or less.
