## CERTIFICATE OF WATER RIGHT

CHARLES SANDERSON.

This Is to Certify, That THOMAS C. & DOROTHY M. CRAIG, AND LYLE G. & VIRGIL D. SANDERSON

of P. O. Box 505, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Sanderson Springs Branches, tributary of Willow Creek, a tributary of Grande Ronde River for the purpose of

irrigation and domestic use for three families,

under Permit No. 16863 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 25, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.048 cubic foot per second, being 0.018 c.f.s. for irrigation, and 0.03 c.f.s. for domestic use.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEL NWL from Spring; in the NWL NEL from Spring Branch; Section 26, in the SEL SEL from Springs, Section 23, all being within Township 1 North, Range 38 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated throughout the irrigation season

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

From Spring in NE! NW!: Section 26

Domestic use for one family & 0.5 acre garden in SEt SWt Section 23

Domestic use for one family & 0.5 acre garden in NE NW Section 26

Township 1 North, Range 38 East, W. M. From Springs in SEt SEt. Section 23

Domestic use for one family & 0.7 acre in SEL SEL

Section 23
Township 1 North Range 38 Root. W. M.

Township 1 North, Range 38 East, W. M. From Spring Creek

5.0 acres in NW# NE#

Section 26 Township 1 North, Range 38 East, W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
