## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That JOHN L. NEALON

of Route 2, Box 279, Central Point , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River, #1 Drain Ditch, #2 Drain Ditch and Slough, tributary of Rogue River, a tributary of Pacific Ocean for the purpose of irrigation

under Permit No. 21410 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 20, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.01 cubic feet per second, being 0.19 c.f.s. from Rogue River; 0.14 c.f.s. from #1 Drain Ditch; 0.53 c.f.s. from #2 Drain Ditch, and 0.15 c.f.s. from Slough.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The points of diversion & located in the as follows: #1 - NE NW , Section 6, Township 36 South, Range 1 West, W.M.; #2 - NW NE , Section 15; #3 - SW SW , Section 11, and NW NW , Section 14; #4 - E NE NE Section 15, all being within Township 36 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
