CERTIFICATE OF WATER RIGHT

This Is to Certify, That c. D. KENDALL

of P.O. Box 306, Central Point , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Kendall Slough.

a tributary of Rogue River

for the purpose of

irrigation

under Permit No. 20620 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 23, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.715 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWL SWL & NEL SWL, Section 16, Township 36 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 42 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.15 acre in NE¹/₄ SW¹/₄

19.2 acres in SW¹/₄ SW¹/₄

25.2 acres in SE¹/₄ SW¹/₄

Land on which water is to be used is a part of that more explicitly described as follows: Beginning at a point on the S. meandering line of Rogue River, which point is N. 81° 30' 10.3 chs. and N. 73° E. 9.20 chs. from the N.W. corner of Govt. Lot 1 in Sec. 17, T. 36 S., R. 2 W., W.M., then S. 49.40 chs. to centerline of county road, then northeasterly along the centerline of the county road 37 chs., more or less, to S.W. corner of land conveyed to H. F. Whetstone, then Northerly on the W. line of Whetstone land 10° 48' W. 4514.2 ft.; thence E. 617 ft.; thence N. on the E. boundary line of Govt. Lot #4 of Sec. 16 to the intersection of the southerly meander line of Rogue River; thence southwesterly to place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
