## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That . W. R. CLASTEAD

of Box 761, Hill City , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon of Link to the use of the waters of North Santiam River, a tributary of Santiam River for the purpose of irrigation under Permit No. 18152 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 19, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.016 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWL SEL, Section 30, Township 9 South, Range 3 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.3 acres in SWH SEH Section 30

Township 9 South, Range 3 East, W. M.

Land on which water is to be used is a part of that more explicitly described as follows:

Beginning at a point 235.8 ft. W. and 44 ft. S. of the N.W. corner of Block 7, in Hobson's Addition to Mill City, Linn County, Ore.; thence running N. 39° 12' W. 238 ft. to the Meander line on the S. bank of the N. Santiam River, thence Easterly upstream along said Meander line 150 ft. to the point due N. of the point of beginning; thence S. to the point of beginning, containing .42 of an acre. Beginning at a point 50 ft. W. of the N.W. corner of Block No. 7 in Hobson's Addition to Mill City, Linn County, Ore., all being in Sec. 30, Twp. 9 S., R. 3 E., W.M.; thence running W. 10 ft.; thence S. 59° 27' W. parallel with Albert Toman N. Line 150 ft.; thence N. 33° 05' W. 102 ft. to the top of the high bank; thence following said high bank Northeasterly to a point due N. of the beginning; thence S. 105 ft. to the point of beginning, containing .46 of an acre, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
