CERTIFICATE OF WATER RIGHT

This Is to Certify, That W. R. OLMSTEAD

of **Box 761, Mill City**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **North Santiam River** a tributary of **Santiam River** for the purpose of **irrigation** under Permit No. **19013** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **September 30, 1949**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.025 cubic foot per second,**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 30, Township 9 South, Range 3 East, W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-fortieth** of one cubic foot per second per acre, or its equivalent and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**0.5 acre in SW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 30**

Township 9 South, Range 3 East, W. M.

Land on which water is to be used is a part of that more particularly described as follows:

Beginning at a point which is **W. 237.1 ft. and S. 55° W. 10 ft.** from the N.W. corner of Block 7, Hobson's Addition to Mill City, Ore., and being in the **SW $\frac{1}{4}$ SE $\frac{1}{4}$** of Sec. 30, T. 9 S., R. 3 E., W. M., Linn County, Ore.; thence **S. 55° W. 100 ft.**; thence **N. 35° 20' W. 233 ft.** to the meander line on the S. bank of the N. Santiam River; thence **E. 100 ft.** along said meander line; thence **S. 35° 20' E.** to the point of beginning, containing **0.5 acre, more or less.**

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
