CERTIFICATE OF WATER RIGHT

This Is To Certify, That GEORGE W. KANOFF, Trustee

of Route 2, Box 58, Band, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Seepage from Timalo Creek, tributary of Deschutes River, and Deschutes River a tributary of Columbia River

Trigation and Domestic under Permit No. 13245 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 25, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.85 cubic foot per second, being 0.35 cubic foot per second for irrigation and 0.50 cubic foot per second for domestic

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from May 23rd to August 20th of each year, 1/80th of one cubic foot per second or its equivalent for each acre irrigated after August 20th of each year, and shall be further limited to a diversion of not to exceed 4 acre feet per acre for each acre irrigated during the irrigation season from April 1st to November 1st,

conform to such reasonable rotation system as may be ordered by the proper state officer.
