CERTIFICATE OF WATER RIGHT

This Is to Certify, That HENRY MARICK

of Rt. 4, The Dalles, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of one well a tributary of Chenowith Creek for the purpose of irrigation

under Permit No. U-294 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 13, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.368 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NE 1/4, Section 36, Township 2 North, Range 12 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.4 acres in NE 1/4 NE 1/4
25.0 acres in NW 1/4 NE 1/4
3.0 acres in SW 1/4 NE 1/4
Section 36

Township 2 North, Range 12 East, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

"Beginning at the 1/4 section corner on the North boundary of Section 36, Township 2 North, Range 12 East, Willamette Meridian running thence South on line through center of Section 36, a distance of 1138 feet, more or less to a point 1451.3 feet North of center of said Section 36; thence South 30° 35' East, 805.2 feet; thence North 34° 56' East, 175.6 feet; thence North 45° 20' East, 216.5 feet; thence North 36° 27' East 258.7 feet; thence North 53° 16' East 269.3 feet; thence North 25° 08' East, 221.1 feet; thence Northeasterly along County Road, approximately 1008 feet, to North boundary of said Section 36; thence West along North boundary of Section 36, 1750 feet; thence the use of the water from the beginning aforesaid is restricted to the lands or place of use herein described.
