## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That**      **GEORGE W. and SUSIE HAWKINS**

of Bandon, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Crooked Creek a tributary of \_\_\_\_\_ for the purpose of irrigation under Permit No. 17460 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 6, 1947,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 8, Township 29 South, Range 14 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 0.1 of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 0.75 acre foot for each acre irrigated in any 30-day period and shall be still further limited to a diversion of not to exceed 6 acre feet per acre during the irrigation season of each year, and shall be still further limited to a diversion of not to exceed 0.05 cubic feet per second,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3 $\frac{1}{2}$  acres in SW $\frac{1}{4}$  NE $\frac{1}{4}$   
Section 8

Township 29 South, Range 14 West, W. M.

Land on which water is to be used is part of that more explicitly described by appropriator as follows:

The W $\frac{1}{2}$  of the SW $\frac{1}{4}$  of the NE $\frac{1}{4}$  Section 8, Township 29 South, Range 14 West, W. M., Coos County, Oregon; Also beginning at the NW corner of the NW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 8, Township 29 South, Range 14 West, W. M., running thence South along the 1/4 section line, 400 feet; thence at right angles East 400 feet; thence North 400 feet to the 1/4 section line running East and West through the center of said Section 8; thence West 400 feet to the place of beginning,

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
